REGISTRATION: Register Online by MARCH 28, 2020! Early Registration is RECOMMENDED for all competitors & coaches. All Early Registration must be Registered and paid Online by March 15, 2020. Online Registration is ONLY available at www.PATU.org. Online Late Registration CLOSES at 11:59pm MARCH 28, 2020 Puerto Rico Time. Unpaid registration will result in an additional \$25 onsite payment fee with no exceptions. **Absolutely No Refunds under any circumstances.**

ENTRY FEES: Competitors: Before MARCH 16, 2020 Additional Event \$30.00 each. One Event \$75.00

Competitors: MARCH 17-MARCH 28, 2020 One Event \$100.00 Additional Event \$30.00 each

Coach (WT Coach Permit NOT Needed for this event) - Before MARCH 16, 2020 \$80.00; From March 16, 2020 \$100

*Late registration fee of \$20 will be added to all regisration from March 16 through March 28, 2020 with no exceptions. Tournament Registration will be CLOSED at 11:59pm, Puerto Rico Time, on March 28, 2020. **Absolutely No Refunds Under Any Circumstances.**

COACH PASS: All Coach Passes can be registered online for \$80.00 each. Coach Passes can be purchased at the Venue for \$100.00, Cash Only. NO WT COACH PERMIT IS NEEDED FOR THIS EVENT. Coach Passes at the San Juan Puerto Rico Open G1 are valid for the Puerto Rico Taekwondo Festival. Coach Passes for Puerto Rico Taekwondo Festival CANNOT be used for San Juan Puerto Rico Open G1.

AWARDS: Beautiful quality Medals will be awarded to 1st, 2nd, and two 3rd places.

SPECTATOR FEES: \$10.00 per spectator 3 Years and Under - Free

ACCOMMODATION: Please see pages 5 & 6 for tournament hotel accommodations.

MANDATORY: All Competitors MUST WEAR White WT approved uniform with White or Black V-Neck collar. Black Belt Poomsae competitors may wear WT approved Y-Neck Poomsae uniforms with Poom or Black Belts.

All black belt sparring competitors must provide their own DAEDO (Gen 1) SENSOR SOCKS, shin guards, arm guards, gloves, groin guards, and mouth guard for their events. Color belts must provide their own shin-Insteps guards, arm guards, groin guard, head protector, mouth guard, and chest protector. Head protector must match chest guard color unless white headgear is worn. Groin guard must be worn under Taekwondo pants. DAEDO Socks are available for sale at the tournament site, but can be purchased online at www.tkdscore.com before the event. Full line of martial arts equipment will be available for purchase at the event venue.

RULES: WT and Organizing Committee rules will govern this event with emphasis on fairness and traditional martial arts values.

SPARRING ROUNDS: All Ages & Color Belts - Single elimination bracket, 2 Rounds, 1 minute round with 30 second rest period. Black Belts - Single elimination bracket, 2 Rounds, 90 second round with 30 second rest period. Tournament Chairman has the right to change the duration of rounds and official decisions without notices.

WEIGH - INS: All Sparring Competitors will weigh in at the staging area on April 4, 2020.

POOMSAE: All Color Belt & Black Belt Poomsae competitors will compete in 1 Round of Compulsory Poomsae of their choice based on their belt rank. Black Belt Poomsae competitors must select one Black Belt Compulsory Poomsae. Color Belt Competitors must select one Taeguek Poomsae based on their belt rank.

> ***All Board Breaking Competitors must purchase official approved regulation-size demo boards through the event vendor on site at USD\$3.00 per board, with no exceptions.***

DISTANCE BREAKING RULES (Flying Side Kick): Winner will be the athlete who jumps the farthest without stepping on or past the fault line while breaking one regulation-size board within two attempts. A second attempt is given if the competitor steps on the fault line or does not break the board in the first attempt, with no penalties. Referees will act as the board holder of this event with no exceptions. HEIGHT BREAKING RULES (Jump Front Kick): Winner will be the athlete who jumps the highest while breaking one regulation-size board. A second attempt is given if the competitor does not break the board in the first attempt, with no penalties. Referees will act as the board holder of this event with no exceptions. WEAPONS COMPETITION RULES: Maximum set up and clean up time is 1 minute, Maximum time to compete the demonstration is 1 minute.

**Please note that ALL Changes in registration will result in a mandatory \$25.00 Administration Fee per change request after online registration is paid/confirmed; with NO EXCEPTIONS. In consideration of your acceptance of my entry for Puerto Rico Open Taekwondo Championships to be held on April 2-5, 2020 at San Juan, Puerto Rico, I do hereby, for myself, my heirs, executors, and administrators waive, release and forever discharge any and all rights and claims for damages, including bodily injury which I may have or which may occur to me against the referees, medical staff and all members of this championships or their respective officers, representatives, successors, and/or assigns and against any competitor for any and all damages which may be sustained by me in connection with my associates with or entry into this championship event, or which may arise out of traveling to, participating in and returning from this tournament event. I am not entering this competition in reliance or any written or oral representation by the Puerto Rico Taekwondo Federation and World Taekwondo regarding the applicable rules and qualifications of the judges and referees. I am in good health and physical condition to participate in this tournament. I fully understand that my entry fee is non-refundable. I consent that any picture furnished by me or any pictures taken of me in connection with the championships can be used for publicity, promotion or television showing, and I waive all compensation in regard, thereto. I understand that Martial Arts is a body contact sport and I further understand all the contents of the rules and general information which was published by the organizing committee and I agree to them in their entirety.

- I understand the nature of San Juan Puerto Rico Open Taekwondo Championship activities and believe that my experience and capabilities, or that of the minor child, to be qualified to participate in these events which to be held in Puerto Rico. I UNDERSTAND THAT PUERTO RICO TAEKWONDO FEDERATION AND WORLD TAEKWONDO TOURNAMENT ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH.
