ELIGIBILITY AND FEES:

This is an "Open" event, open to all Red and Black belt Competitors of and Coaches from all countries.
- WT Global Athlete License (GAL) is NOT required for this event.
- All Competitors must hold passport or birth certificate of the country they will represent.
- Competitors will compete at the age based on their birth year.
- All Coaches must be at least 18 years of age.
- WT Coach Permit is NOT required for this event.

- MNA Presidents: **NO PAYMENT REQUIRED** but must register via www.WTPanAm.org. Registration is non-transferrable and subject to OC verification.

PAYMENT TERMS & EARLY REGISTRATION DISCOUNTS

Athletes and Coaches must pay IN FULL by the early, regular or final registration deadline to receive the registration fee at that rate. If an Athlete registers during the Early Registration period but do not pay by the Early Registration deadline, the individual will have to pay the fee that is applicable based on the date of which payment is made.

EVENT ADD ON AFTER REGISTRATION:

DRAW OF LOTS:

All Senior competitors will be seeded according to WT World Ranking as per April 6, 2020. All other Kyorugi divisions will use single elimination with a randomized computer draw. All Poomsae (Individual Under 30 & Under 40 divisions) will use single elimination with a randomized computer draw. All other Poomsae divisions will use cut-off system with a randomized computer draw. The draw sheets and brackets will be available on www.WTPanAm.org and the "World Taekwondo Pan America – PATU" Facebook Page by 11:55 PM PST the night before the competition of the respective Kyorugi and Poomsae divisions. All competitors that failed to show up or failed to make weight will be removed from the bracket.

COMPETITION REGULATIONS:

- Best Kyorugi & Poomsae Referee Awards: Male & Female
- Best Kyorugi & Poomsae Coach Awards: Male & Female

INDEMNITIES:

Participants without proper participation registration entry and valid medical insurance coverage will not be allowed to compete at the WT President's Cup. **Liability waivers must be signed** by participants (or by parent or legal guardian for competitors ages 18 and under) prior to the release of credentials. Government issued photo ID is required to pick up credentials during **check-in AND** at **weigh-in**.

VISA ENTRY:

- All participants are responsible for their own visas and airfares.
- **Invitation letters WILL NOT BE ISSUED TO REGISTRANTS WHO HAVE NOT SUBMITTED REGISTRATION AND PAYMENT ONLINE** prior to requesting Visa Invitations.

- The Organizing Committee shall provide each participating WT International Referee with honorarium of USD\$100.00 per day for 2 days of competition, plus meal allowances.

NATIONAL REFEREES:

- WTPA will appoint PATU Kyorugi and/or Poomsae Referee and National Referees from any country to officiate at the 2020 Pan Am Grand Slam Championships.
- Round-trip Airfare shall be borne by each participating Referee.
- The Organizing Committee shall cover three (3) nights of room and board expenses (check-in in early morning of April 10th; checkout before Noon of April 13th) to PATU/National Referees.
- The Organizing Committee shall provide each participating PATU/National Referee with honorarium of USD\$50.00 per day for 2 days of competition, plus meal allowances.

WILDCARD INVITATIONS OFFERED TO TOP 4 MEDALISTS

*** No Senior Wild Cards will be offered at this event. ***

- All Black Belt Competitors and Red Belts Competitors who will compete in the Black Belt division(s) in 2020 and/or 2021 are qualified to receive Wild Cards based on the following criteria.
- Red Belt Wild Card Winners MUST compete as Black Belts at the 2020 and/or 2021 Pan Am Youth, Cadet, Junior & Ultra Championships. (Red Belt Wild Card Winners must complete Black Belt Verification Form prior to competing in the Black Belt Division(s) at the 2020 and/or 2021 Pan Am Youth, Cadet, Junior & Ultra Championships.) Athlete must be from Pan Am countries.

JUNIOR WILD CARD QUALIFICATION:

The top four medalist of each of the following Kyorugi divisions, maximum of ONE invitation per country, will be eligible to receive Wild Card Invitations to the 2021 Pan Am Junior Kyorugi & Poomsae Championships:

- Junior (Ages 15-17) Black Belts & Red Belts
 - Sparring, Recognized Poomsae: Individual, Pair
- Under 17 Black Belts
 - Recognized Poomsae: Team
 - Freestyle Individual, Freestyle Pair & Mixed Team

Junior Wild Card Selection Guidelines:

1. The Wild Card invitation is available for ONE competitor per country in each of the Black and Red Belt Junior Kyorugi division (Male and Female), each Black and Red Belt Junior Poomsae division (Recognized Poomsae: Individual, Pair, Team) and each Black Belt Under 17 Freestyle Poomsae division (Individual, Pair, Team).
2. In the event that more than one competitor wins from the same country, ONLY the highest ranked medalist from that country will receive the Wild Card, while the lower ranked medalist from the same country will NOT be entitled to a Wild Card in that division.
3. In the event that the two Bronze Medalist are from the same country, ONLY the competitor that lost to the Gold Medalist will receive the Wild Card and the other Bronze Medalist from the same country will NOT be entitled to a Wild Card in that division.
4. Poomsae will follow the same guidelines as stated above.
5. In the event that there is a tie between the two Bronze Medalist and they are both from the same country in a Cut-Off Poomsae division, WT Poomsae Tie Break Rules will be followed and ONLY the higher ranked medalist will be awarded the Wild Card, while the other lower ranked medalist winner from the same country will NOT be entitled to a Wild Card in that division.
6. Wild Card winners in the Junior divisions will be entitled to weight changes at the 2021 Pan Am Junior Championships. Fees may apply.
7. Wild Card winners in the Junior divisions who were born in 2003 will NOT be entitled to compete at the 2021 Pan Am Junior Championships as Pan Am Senior Championships will not be offered in 2021.
7. WT Global Athlete Licensure (GAL) will be required to complete at the 2021 Pan Am Junior Championships.

Explanation: For example, Canada wins Gold, Canada wins Silver, and Mexico & Mexico wins both Bronze. ONLY the Gold Medalist from Canada will win the Canada Wild Card and ONLY the Bronze Medalist from Mexico that lost to the Gold Medalist will win the Mexico Wild Card. In this case, ONLY 2 competitors will receive a Wild Card from this division.

WILD CARD INVITATIONS WILL ONLY BE GRANTED TO THE TOP FOUR (4) MEDALISTS FROM PAN AM COUNTRY ALL WILD CARD DIVISIONS, WITH NO EXCEPTIONS.

CADET WILD CARD QUALIFICATION:

The top four medalist of each of the following Kyorugi & Poomsae divisions, maximum of TWO invitations per country, will be eligible to receive Wild Card Invitations to the 2021 Pan Am Cadet Championships:

- Cadet (Ages 12-14) Black Belts & Red Belts
 - Sparring; Recognized Poomsae: Individual, Pair, Team

Cadet Wild Card Selection Guidelines:

1. **Cadet Kyorugi:** In the event that more than two competitors win the Wild Card division from the same country, the two highest medal winners will receive the Wild Card Invitations while the 3rd lower ranked winner from the same country in the same division will NOT be entitled to a Wild Card. In the event that two bronze medal winners are from the same country and the gold or silver medal winner is from the same country, the lower ranked athlete from the same country will NOT be entitled to the Wild Card.
 2. **Cadet Recognized Poomsae:** In the event that two bronze medal winners hold the same score from the same country and the gold or silver medal winner is from the same country, the bronze medalist who has the best Presentation Score in the Final round will win the Wild Card; if the presentation score in the final round is also a tie, the Wild Card will be granted to the bronze medalist with the best Accuracy Score in all rounds of the Recognized Poomsae division.
 3. Wild Card winners in the Cadet divisions who were born in 2006 will be entitled to compete at the 2021 Pan Am Junior Championships.
 4. Wild Card winners in the Cadet divisions who were born in 2006 will be entitled to weight changes at the 2021 Pan Am Junior Championships. Fees may apply.
 7. WT Global Athlete Licensure (GAL) will be required to complete at the 2021 Pan Am Cadet Championships.
- Explanation:** If Canada wins Gold, USA wins Silver, Mexico & Canada win Bronze medals, the Gold and Bronze medalists from Canada will win two Wild Cards for Canada, and USA and Mexico athletes will each win a Wild Card. In the event when USA wins Gold, Silver, Bronze and Canada is in fifth (5th) place; the Gold and Silver medalists from USA will win two Wild Cards and no further Wild Cards will be offered. Wild Cards are ONLY offered to athletes who finish in the Top Four (4) places in each division with no exceptions.

YOUTH & ULTRA WILD CARD QUALIFICATION:

The top four medalist of each of the following Kyorugi & Poomsae divisions will be eligible to receive Wild Card Invitations to the 2020 **AND** 2021 Pan Am Youth & Ultra Championships:

- Youth (Ages 6-7, 8-9, 10-11) & Black Belts & Red Belts
 - Sparring; Recognized Poomsae: Individual, Pair, Team
- Ultra (Ages 33+) Black Belts & Red Belts - Sparring
- Under 50, Under 60, Under 65, Over 65 Black Belts & Red Belts
 - Recognized Poomsae: Individual

Youth & Ultra Wild Card Selection Guidelines:

1. Wild Card winners in the Youth divisions (Ages 6-7, 8-9, 10-11) will be entitled to compete in the 2020 **AND** 2021 Pan Am Youth Championships based on the winners' age by their birth year in 2021.
2. Wild Card winners in the Youth divisions who were born in 2009 will be entitled to compete as Cadet in the 2021 Pan Am Cadet Championships.
3. Wild Card winners in the Youth divisions are permitted to compete in their appropriate Youth age division in the 2020 and 2021 Pan Am Youth Championships.
4. Wild Card winners in the Ultra divisions are permitted to compete in their appropriate Ultra age division in the 2020 and 2021 Pan Am Ultra Championships.
5. Wild Card winners in the Youth Kyorugi divisions will be entitled to weight changes in the 2021 Pan Am Youth & Cadet Championships. Fees may apply.
6. Red Belt Wild Card Winners at the 2020 Pan Am Grand Slam MUST compete as Black Belts at the 2020 and/or 2021 Pan Am Youth & Ultra Championships.

Kyorugi Rules and Competition Format

Organizing committee has the right to change, modify the duration of rounds, divisions and make official decisions without prior notices.

HEAD OF THE TEAM / TECHNICAL MEETING:

WTPA technical officials shall conduct the Head of Team meeting on Friday, April 10, 2020 at 6:00 PM. Head of the team meeting will be held at the Oregon Convention Center, Portland, Oregon.

WTPA Technical Delegate and Organizing Committee have the rights to change, modify the duration of rounds, and combine divisions at the Head of Team meeting. The official drawing will be done by the computer automatically and posted on to the PATU Facebook Page "[World Taekwondo Pan America – PATU](#)".

OFFICIAL UNIFORM:

All Black Belt Kyorugi competitors must wear WT approved white uniform (dobok) with black V-neck in good condition. Red Belt Kyorugi competitors may wear WT approved white uniform (dobok) with black or white V-neck in good condition. Patches, embroidery, logos, team names, country names, competitor names, and stripes are permitted on uniforms. **NO TAPING IS ALLOWED ON ANY PART OF THE UNIFORM.**

COACHES ATTIRE:

All coaches must oblige to wearing business suits (tie optional) for the semifinals and final rounds. Coaches that do not follow the dress code will not be allowed to enter the field of play during finals and semifinals. Absolutely no jeans, open-toe shoes, nor hearing devices/phones at coach seats.

KYORUGI EQUIPMENT:

Organizer will be using DAEDO Generation 2 PSS system for all Kyorugi divisions.

All Youth, Cadet, Junior, Senior, Ultra divisions will be using DAEDO Gen 2 Body & Headgear provided by the OC. All competitors are **REQUIRED** to purchase and use their own Daedo socks for the Kyorugi competition. Daedo socks can be purchased by visiting the Daedo sales booth at the event.

All Kyorugi competitors are responsible for supplying their own gloves, arm, shin guards, groin guards, and mouth guards. **No eye-glasses or goggles, prescription or non-prescription, are allowed with no exceptions.**

RECOGNIZED BRANDS:

All contestants are required to wear WT recognized doboks and protective equipment. The latest version of WT recognized manufacturers' list is available at the website of World Taekwondo <http://www.worldtaekwondo.org/wtf-partnersrecognized/>

Please Note: Organizer reserves the rights to disallow any uniform or equipment if it is found to be offensive or degrading in any fashion.

Kyorugi Competitors **CANNOT** participate in more than one (1) weight division in the same age category.

KYORUGI COMPETITIONS:

Instant Video Replay (IVR) will be used in all divisions.

YOUTH CATEGORIES (6-7 Years, 8-9 Years, 10-11 Years):

Single elimination bracket, 2 rounds, 90-second with 1-min. rest period.

CADET CATEGORY (12-14 Years) & JUNIOR CATEGORY (15-17 Years):

Single elimination bracket, 3 rounds, 90-second rounds with 1-min. rest period.

SENIOR CATEGORY (17-32 Years):

Single elimination bracket, 3 rounds, 2-minute rounds with 1-min. rest period.

ULTRA CATEGORY (33+ Years):

Single elimination bracket, 3 rounds, 90-second rounds with 1-min. rest period.

WEIGH-IN:

The weigh-in of the competitors will take place at the designated weigh-in area of the Oregon Convention Center **one (1) day prior** to the start of the respective weight category of competition ([see Page 7](#)).

- **Competitors MUST change weight BEFORE their 1st weigh-in attempt.** A test scale will be available in the weigh-in area.

- All competitors who failed to report to weigh-ins during their designated time or failed to make weight during the allotted time slot will be disqualified and removed from the brackets.

- All weigh-in competitors must present a form of government issued photo ID.

- All **Male and Female Youth, Cadet, and Junior** competitors must wear WT approved uniform (dobok) pants and T-shirt for official weigh-in. A 0.3 kg tolerance will be granted for the uniform pants and T-shirt.

- All Senior and Ultra Male competitors must wear a minimal of underpants. All Senior and Ultra Female competitors must wear a minimal of underpants & brassieres. A 0.1 kg tolerance will be granted for the undergarments.

HEAD OF THE TEAM / TECHNICAL MEETING:

WTPA technical officials shall conduct the Head of Team meeting on Friday, April 10, 2020 at 6:00 PM. Head of the team meeting will be held at the Oregon Convention Center, Portland, Oregon.

Designated Poomsae will be drawn at the Head of Team Meeting Friday, April 10, 2020 at 6:00 PM. Designated Poomsae will be posted on WT Pan America Facebook page "[World Taekwondo Pan America – PATU](#)" at 11:55 pm on April 10, 2020.

The WT Technical Delegate and Organizing Committee have the rights to change or modify the competition format and combine divisions without prior notifications.

OFFICIAL UNIFORM:

All Poomsae competitors must wear the proper WT approved uniform (dobok) with the proper Y-neck in good condition. Poom Belts MUST be worn for competitors in Poom collared Y-neck Poomsae uniforms. WT approved white V-neck uniforms and Poom collared Y-neck Poomsae uniforms are permitted for Red Belt Competitors.

COACHES ATTIRE:

POOMSAE COMPETITION RULES & RANKING:

Current WT Poomsae Competition Rules and WT Poomsae Ranking bylaws will govern the 2020 Pan Am Grand Slam.

RECOGNIZED CATEGORY (Individual, Pair, Team):

Minimum: None; Maximum: 90-seconds; Rest: 30-seconds

FREESTYLE CATEGORY (Individual, Pair, Mixed Team):

Minimum 90-seconds; Maximum: 100-seconds

NON-SENIOR POOMSAE DIVISIONS:

Cut-Off system will be used for All Youth, Cadet, Junior, Under 50, Under 60, Under 65, Over 65 Recognized Poomsae divisions with a random computer draw. All competitors who fail to report will be disqualified.

SENIOR POOMSAE:

Single Elimination for All Senior Recognized Individual Poomsae divisions (Individual Under 30 & Under 40) with a 100% seeded draw. All competitors who fail to report will be disqualified.

SINGLE ELIMINATION SYSTEM:

The latest WT Poomsae single elimination rules will be in effect. Competitors shall perform two (2) designated compulsory Poomsae per round.

CUT-OFF SYSTEM:

Preliminaries: When 20 or more competitors are participating; competition shall start from the Preliminary Round with division of groups at different rings. Competitors shall perform one (1) designated compulsory Poomsae, and half of each group's competitors shall advance to the Semi-Final Round based on the highest scores. In the Preliminary Round, each group may be judged by a different group of judges. If the number of competitors is odd, the number of competitors will be rounded to an even number. Ex.: If there are 23 competitors in the division, it will be considered as 24 competitors and 12 shall advance to the Semi-Final Round.

Semi-Final Selection: When 9 to 19 competitors are participating; competition shall start from the Semi-Final Round. Competitors shall perform one (1) designated compulsory Poomsae, and 8 competitors shall advance to the Final Round based on the highest scores.

Final: When 8 or fewer competitors are participating, competition shall start from the Final Round. Competitors shall perform one (1) designated compulsory Poomsae, and the top four individual competitors/pair/team shall be awarded medals based on their rank in the Final Round. In the case of a tie, WT Poomsae Tie Breaking Rules apply. Both 3rd and 4th place is awarded with bronze medals.

DEMO TEAM SCORING:

Based on the following order of superiority in ascending order:

1. Synchronization Technique (20%).
2. Excitement on the performance (20%).
3. Successful completion of Taekwondo Techniques (20%).
4. Entertainment Generated (20%).
5. Display of Precision, Speed, and Power (20%).

Major Deduction (0.5 points):

- Any part of the body above the ankle bone that touch the mats.
- Crossing the boundary line with both feet.
- Under or Over time
- Inability to complete all four (4) mandatory skills.
- Assistance from team members in completing aerial techniques.
- Assistance from board holders by hitting boards to breakers' feet.
- Extreme remarkable and offensive behavior amongst coaches and competitors; failure to obey directions from referees / officials.

Minor Deduction (0.1 points):

- Failure to break boards or execute board breaking techniques.
- Losing balance, extended pause, lack of synchronization and harmony.

Organizing committee has the rights to changes, and modifications without prior notices.

OFFICIAL UNIFORMS & BOARDS:

All Black Belt competitors must wear WT approved white uniform (dobok) with black V-neck in good condition. All Red Belt competitors must wear WT approved white uniform (dobok) with black or white V-neck in good condition. Patches, embroidery, logos, team names, country names, Competitor names, and stripes are permitted on uniforms. **Y-neck Poomsae uniforms are not permitted.**

- Competitors **MUST** purchase demo boards at Accreditation on April 10 – 12, 2020 at \$3 per board for fairness.

DISTANCE & HEIGHT BOARD BREAK:

- Each ring will be assigned ONE Referee to hold demo boards (purchased on-site by Competitors) for ALL Competitors in the same round; **Coaches are NOT allowed to hold boards for their Competitors with no exceptions.**

- Each Competitor (and Competitor's Coach) will have 60 seconds to set up, position Referee/Board Holder, **AND** complete the break for the event. **Only one (1) demo board permitted.**

- Coaches **MUST** fully remove themselves from the mat area before Competitors begin the board breaking competition.

- Shoes are **NOT** permitted in any Board Breaking events.

- Competitors will **ONLY** receive up to TWO attempts.

- In the event when all Competitors in the same round fail to break their boards after first AND second attempts, the Referees shall grant Gold, Silver, and Bronze based on the quality of the execution of techniques. **Protest will not be granted under any circumstances.**

DISTANCE BOARD BREAK:

- Competitors **MUST** jump from behind the foul line. If the Competitors start the leap with any part of the foot past the foul line, the jump is declared a foul and no distance will be recorded; however, the Competitors will be granted a second attempt **ONLY if the foul takes place on the first attempt.**

- A second attempt will **ONLY** be granted to Competitors who 1). Fail to break the board *on the first attempt*, or 2). step past the foul line *on the first attempt*; **no points will be deducted as a result.**

- Competitors can jump from any point behind the foul line, but the recorded distance will always be measured from the foul line, perpendicular to the position of ***where the rear foot lands on the mat when a successful board break is executed.***

- The Competitor who accomplishes a successful board break with the longest distance from the foul line receives the highest score and wins Gold, ***in regardless of whether the board break takes place on the first or second attempt.***

- In the event when two Competitors' successful board break distance from the foul line is a tie, the Referees will grant merit based on the quality of the execution of their Flying Side Kick techniques.

- Boards will be held at Athletes' BELT LEVEL height with no exceptions.

HEIGHT BOARD BREAK:

- Competitors may use a running start from inside the competition area; however, running start is **NOT** required.

- A second attempt will **ONLY** be granted to Competitors who fail to break the board *on the first attempt*; **no points will be deducted as a result.**

- The recorded distance will always be measured from the floor, perpendicular to the position of *where a successful board break is executed.*

- The Competitor who accomplishes a successful board break with the highest distance from the floor receives the highest score and wins Gold, ***in regardless of whether the board break takes place on the first or second attempt.***

- In the event when two Competitors' successful board break height from the floor is a tie, the Referees will grant merit based on the quality of the execution of their Jump Front Kick techniques.

CREATIVE BOARD BREAK:

- Demo boards (purchased on-site by Competitors) will be held by the Competitors' Coach(es) or assigned board holders.

- **Minimum of one (1) and maximum of thirty (30) boards may be used.**

- Each Competitor will have 60 seconds to set up and clean up, position Referee/Board Holder, **AND 60 seconds** to complete the routine.

- Only **TWO** attempts can be made to complete each board break.

- **Hand and foot techniques only**; no tables, chairs, or assisting equipment.

- Points are given in the following order of superiority:

- Turning Jump Kicks
- Jump Kicks
- Basic Kicks
- Hand Techniques

- The Competitor who breaks the most number of boards will be declared the winner.

- The Competitor who performs more superior techniques will win, should the same number of boards be broken by other Competitors in the same round.

- **Deductions should be factored if:**

- More than two attempts are made for each board breaking technique
- Set up and clean up exceeds 60 seconds
- Routine exceeds 60 seconds
- Poor clean up of broken boards
- Disrespectful behaviors demonstrated by Athletes and Coaches

- In the event when two Athletes' successful board break is a tie based on number of superior board breaks, the Referees will grant merit based on the quality of the execution of the entire routine.

- In the event when all Competitors in the same round fail to break their boards after first AND second attempts, the Referees shall grant Gold, Silver, and Bronze based on the quality of the execution of techniques.

- **Protest will not be granted under any circumstances.**

- Board holders and Coaches may wear closed-toe shoes.

- Board holders must hold valid competitor/coach/media passes to enter Field Of Play.
